# **English Indices of Deprivation 2019** Supplementary indices data

# Introduction

This report presents the findings of the English Indices of Deprivation supplementary indices data for South Gloucestershire. The Index of Deprivation 2019 includes two supplementary indices: the Income Deprivation Affecting Children Index (IDACI) and the Income Deprivation Affecting Older People Index (IDAOPI).

The **Income Deprivation Affecting Children Index** (IDACI) measures the proportion of all children aged 0 to 15 living in income deprived families. It is a subset of the Income Deprivation Domain which measures the proportion of the population in an area experiencing deprivation relating to low income. The definition of low income used includes both those people that are out-of-work, and those that are in work but who have low earnings (and who satisfy the respective means tests).

The **Income Deprivation Affecting Older People Index** (IDAOPI) measures the proportion of all those aged 60 or over who experience income deprivation. It is a subset of the Income Deprivation Domain which measures the proportion of the population in an area experiencing deprivation relating to low income. The definition of low income used includes both those people that are out-of-work, and those that are in work but who have low earnings (and who satisfy the respective means tests).

#### Interpreting the results

The supplementary data, like the main domain data report, is based on geographical areas called Lower Level Super Output Areas (LSOAs). LSOAs are small areas designed to be of a similar population size with an average of approximately 1,500 residents or 650 households. There are currently 32,844 LSOAs in England and 165 in South Gloucestershire.

Every LSOA in England (32,844) has been assigned a score and a rank for each both of these supplementary datasets. The most deprived LSOA is given a rank of 1, and the least deprived a rank of 32,844. The ranks show how an LSOA compares to all other LSOAs in the country and are easily interpretable.

Caution should be exercised when making comparisons between the ID 2019 and previous indices. It would be valid to state that an area showed an increased level of deprivation relative to other areas if it was ranked in the most deprived 40% of areas nationally based on the 2015 indices but ranked within the most deprived 20% according to the 2019 indices. However, it would not necessarily be correct to state that the level of deprivation in the area had increased on some absolute scale, as it may be the case that all areas had improved, but that this area had improved more slowly than other areas and so been 'overtaken' by those areas. Similarly, the overall rank of an area may not have changed between ID2019 and ID2015, but this does not mean that there have been no changes to the level of deprivation in the area.

Tables, graphs and maps in this report refer to 'deprivation quintiles'. Quintiles are fifths, the 1<sup>st</sup> quintile being the most deprived fifth (or 20%) and the 5<sup>th</sup> quintile being the least deprived fifth (or 20%).


In this report deprivation quintiles are used to show how LSOAs relate to others within a defined area. Maps and tables in this report use the following schema:



Meaning Q1- Most deprived 20% in England Q2- Most deprived 20-40% in England Q3- Most deprived 40-60% in England Q4- Least deprived 20-40% in England Q5- Least deprived 20% in England

# **Quintiles 2019**

The chart below shows the distribution of LSOAs by quintiles for the two supplementary indices and the main income deprivation domain.



#### Chart 1: Distribution of LSOAs by quintile

Overall, the proportion of LSOAs falling into each quintile for both of the supplementary indices largely reflects the spread seen in the main income domain, with the largest proportion of LSOAs being in the least deprived 20% nationally. However, the data suggests that income deprivation levels are slightly higher amongst children with a greater proportion of LSOAs for this group falling into the 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> quintiles and slightly lower proportion in the least deprived quintiles (4th and 5th) when compared to the overall income domain.


# Income deprivation affecting children

This data looks at the proportion of children within each LSOA living in income deprived families.

#### Key findings

- 54 LSOAs are in the least deprived 20% nationally, that is 33% of the LSOAs in South Gloucestershire.
- The most deprived LSOA for income deprivation affecting children is Pendennis Road in Staple Hill & Mangotsfield (E01014977). It is ranked 3,495<sup>th</sup> nationally and falls into the most deprived 20%.
- Table 1 shows that of the 20 most deprived LSOAs in South Gloucestershire, 18 of these have either stayed in the same quintile since 2015 or have fallen into a worse quintile.
- 4 LSOAs fall into the most deprived quintile 2% of all LSOAs in South Gloucestershire.
- The least deprived LSOA for income deprivation affecting children is the Bromley Heath Infants and Junior school area in Frenchay and Downend ward (E01014901). This LSOA is ranked 32,602<sup>nd</sup> nationally.
- The Hanham Green / Hanham Hall hospital area in Hanham (LSOA E01014921) has seen the greatest relative decrease in deprivation, falling 2 national quintiles (from Q5 to Q3) and dropping 13,920 rank positions.
- E01015010 (Brookthorpe/Longford area in Yate Central ward) is the LSOA that has seen the greatest relative improvement, rising 10,049 rank positions nationally and moving from quintile 2 to quintile 4.






# Income deprivation affecting older people

This data looks at the proportion of those aged over 60 within each LSOA living in income deprivation.

#### Key findings

- 69 LSOAs are in the least deprived 20% nationally, that is 42% of the LSOAs in South Gloucestershire.
- The most deprived LSOA in regards to income deprivation affecting older people is Pendennis Road in Staple Hill & Mangotsfield (E01014977). It is ranked 6,462<sup>nd</sup> nationally and falls into the most deprived 20%. This is the only LSOA in South Gloucestershire in the most deprived quintile for this domain.
- The least deprived LSOA is the Somerset Avenue area of Yate North ward (E01015016). This LSOA is ranked 32,587<sup>th</sup> nationally.
- The Meadowbrook primary school area in Bradley Stoke South (LSOA E01014880) has seen the greatest relative decrease in deprivation, falling 1 national quintile (from Q5 to Q4) and dropping 8,321 rank positions.
- E01014892 (Culverhill and Rodford schools area in Dodington ward) is the LSOA that has seen the greatest relative improvement, rising 6,109 rank positions nationally and moving from quintile 3 to quintile 4.



#### Summary

Overall, income deprivation in South Gloucestershire is low with the largest proportion of LSOAs falling into the least deprived 20% nationally for both supplementary indices in 2019. However, whilst the number of LSOAs in the most deprived 20% is low, it highlights that there are still areas of deprivation in regards to income despite an overall indication of limited deprivation. Pendennis Road (E01014977) is the lowest ranked LSOA for both income deprivation affecting children and older people and falls into the most deprived 20% nationally for both of these supplementary indices. The more deprived areas for both of these supplementary datasets tend to be in urban areas throughout South Gloucestershire.

There has been little change in the distribution of LSOAs in each quintile between 2015 and 2019 with the overall trend remaining largely the same. The most deprived areas in terms of deprivation affecting children and adults are mostly unchanged suggesting there has been little improvement in our most deprived areas.

Income deprivation has a slightly greater impact on children in South Gloucestershire than older people with 4 LSOAs in Q1 for income deprivation affecting children compared to 1 for older people. Furthermore, the measure for income deprivation affecting older people sees 69 LSOAs in the least deprived quintile compared to 54 for children.
