### The Proposal:

South Gloucestershire Council is seeking a local community organisation/charity to run the centre.

The Council are keen to ensure that the building will be a vibrant hub for the local community.

#### Location

The community centre is located in Cadbury Heath, within Oldland Parish, adjacent to Coronation Park with access from Park Road. Please see the location plan below.

### Description

The building is a purpose-built community and youth centre with an adjacent sports pavilion.

#### **Community/Youth Centre:**

This is a single-storey modern building constructed and opened in 2015. Please see floor plan below.

The entrance to the Community Centre side opens into an open plan café area, with kitchen and adjacent bar. There are three activity meeting rooms, office and ancillary accommodation. Behind the café area is a large multi-functional hall.

The Youth Wing has a separate access leading to a partitioned part of the building, which includes a large activity room with fitted kitchen. The hall and one of the meeting rooms can also be accessed from the youth wing and designed to be multi-functional.

Use of the Youth Wing by South Gloucestershire Council or a partner for delivery of a youth club is expected to be included in any Operator's business plan. Further details will be provided to interested parties.

The external area includes a large car park, small terrace from the café/bar area onto Coronation Park.

#### **Sports Pavilion:**

The Sports Pavilion comprises to one side sports changing rooms and a large common room/ancillary space to the other side of the building. The Pavilion is used by a number of sports teams and further details will be provided to interested parties on SGC expectations.

## Planning

The building currently has planning for the existing use of a community centre and the intention is for this to remain as the predominant use.

#### Services

The property has all the main services, however all interested parties should carry out their own investigation to ensure these are suitable for the intended use.
