

# Traffic management

Traffic management is needed to facilitate the works. This is important for ensuring the public's safety and the safety of the workforce. We understand that construction works are disruptive, and we sincerely apologise for any inconvenience.

## LITTLE BRISTOL LANE

As part of the enabling works, SGC Streetcare will permanently realign Little Bristol Lane to make space for the station platforms and footbridge – to be delivered later in the

#### construction programme.

## LITTLE BRISTOL LANE CLOSURE AND DIVERSION ROUTE



These works will require Little Bristol Lane to be closed for through traffic from Monday 3 February until the end of June 2025. Access will be maintained to properties on Little Bristol Lane adjacent to the works.

- A diversion route along Manor Lane will be in place for the duration of these works. See map for the diversion route (marked in green).
- Use of the footway for pedestrians will be maintained. Cyclists will be required to dismount and walk along the footway.
- On-street parking on Little Bristol
  Lane will be suspended along the road closure.
- Works will commence at the Manor Lane junction, working northwards in sections.

We recognise that the road closure impacts the Y8, 914 and 917 bus services and we are liaising with the bus operators to confirm temporary amendments to the services.



### **STATION ROAD**

There will be some limited traffic management in place on Station

Road as part of the enabling works to prepare the area that will become the station forecourt. This area will be used as a compound for rail works.

There will be priority boards in place for the first few days when we create access into the site from Station Road, and then for approximately two to three weeks intermittently following that when planned tree-felling takes place. Exact dates are to be confirmed and communicated with local residents and businesses. Access to adjacent properties will be maintained.



### BACKGROUND

The station will provide much-needed access to public transport for approximately 14,500 residents within a 5km radius, reducing car dependency in Charfield, Wotton-under-Edge and surrounding settlements.

The new station will lie at the heart of the village and will be within a ten-minute walk for all Charfield residents. It is anticipated the station would be served by a minimum of one train per hour in each direction.

### **STATION FACILITIES**

#### The station scheme includes:

- North and southbound platforms, with seating and shelters

- A connecting pedestrian footbridge, with stairs and lifts
- Ticket machines and real-time passenger information

Local highway improvements.

## **HIGHWAY IMPROVEMENTS**

#### **WOTTON ROAD**

A new signal-controlled pedestrian crossing of Wotton Road near to the junction with Station Road.

#### **STATION ROAD**

- Sections of carriageway and footway to be widened.
- The existing subway under the railway, linking Station Road and Charfield Green, will be closed to traffic but pedestrian and cycling access will be maintained.





#### ITTLE BRISTOL LANE

- Carriageway realignment to provide space for the station platforms and footbridge. The road will remain at least two metres from property boundaries.
- New zebra crossing
- New mini roundabout for Little Bristol Lane at its junction with Manor Lane and Charfield Green to allow vehicles to turn.

### **CAR PARKING**

The scheme includes 23 parking spaces, including accessible bays and electric vehicle charging points in the forecourt area adjacent to the station, accessed from Station Road.

## CONSTRUCTION

South Gloucestershire Council's Streetcare division is undertaking the highway works, i.e. the southern car park, forecourt and highway improvements.

Network Rail's contractor, Octavius Infrastructure Ltd, is undertaking the railway works, i.e. platforms, footbridge and track works.



70 spaces will also be available to the south of the station. Additional on-street parking is being created on Station Road.

Provision for a taxi/minicab rank and dedicated drop-off bays will be provided in the forecourt area.

#### StreetCare and Octavius are working closely

together to coordinate their construction activities to minimise disruption and timescales as far as possible.
