### **Spotlight: Sexual Health**

South Gloucestershire

Delivering for you

- Good sexual and reproductive health matters to individuals and communities, whose needs will vary according to a range of physical, emotional, social, cultural and economic factors.
- It is influenced by a range of factors which can in turn result in inequalities in sexual and reproductive health outcomes between different populations.
- Groups that are disproportionately affected include young people under 25, gay and bisexual men and men who have sex with men (GBMSM) and some ethnic groups, including Black African and Caribbean people and Gypsy, Roma and Travellers; and targeted interventions are often required.
- There are certain core needs common to all, including the availability of high-quality information and education to make informed decisions, freedom from stigma and discrimination, and access to high quality prevention, testing, diagnostic and treatment services and interventions.
- Responsibilities for commissioning sexual health services are spread out across the health and social care system. Local Authority Public health teams are mandated to commission elements of this.

## **Sexual Health in South Gloucestershire**



Sexual health outcomes in South Gloucestershire are generally good when benchmarked against England.

- New STI diagnoses are lower than England average
- Diagnostic rates for syphilis and gonorrhoea are lower than England averages
- The proportion of females aged 15 to 24 years screened for chlamydia increased in 2024 to above England average having been below for a number of years.
- The chlamydia detection rate also increased although remains below the national benchmarking goal
- Diagnosed HIV prevalence rate is low, however HIV testing rate is significantly lower than England average
- Under 18s conception rate is lower than England average

#### Local authority responsibilities



- Local Authorities are mandated to commission comprehensive open access sexual health and reproductive health services, including:
  - free testing and treatment for sexually transmitted infections (STI)
  - notification of sexual partners of infected persons,
  - advice on, and reasonable access to, a broad range of contraception, and advice on preventing unplanned pregnancy.
- Integrated Care Boards (ICB) are responsible for commissioning abortion services.



#### **Sexual Health Services in South Gloucestershire**

- Integrated sexual health services have been co-commissioned across the Bristol, North Somerset and South Gloucestershire (BNSSG) area for over a decade. In 2015 the then CCG, now Integrated Care Board (ICB), collaborated with local authorities to include abortion services in the clinical contract, and Bath and North East Somerset collaborated to co-commission the Chlamydia Screening Programme within the main clinical contract.
- From 1st April 2025 we have a new Integrated Sexual Health Service which continues to be commissioned across BNSSG (and includes BANES for the Chlamydia and Gonorrhoea Screening Programme). The abortion services are now commissioned separately by the ICB.

#### **BNSSG Integrated Sexual Health Service**

- The new BNSSG Integrated Sexual Health service, named <u>Yuno</u> comprises of three elements:
  - Digital 'front door': Delivered by SH:24
  - Health Promotion: Delivered by Brook
  - Clinical provision: Delivered by UHBW
- The service offers free and confidential access to a wide range of services. It's managed by a team of experienced sexual health clinicians and other healthcare professionals and ensures service users receive trusted, high-quality and timely care
- The service has a clinically supported website, which acts as a digital 'front door', providing convenient and confidential ways to get expert advice, contraception and testing and treatment for STIs.
- By expanding digital support alongside in-person care, the new service aims to make it easier for people to access sexual and reproductive health services, helping improve health outcomes.

## South Gloucestershire clinical provision



- Yuno clinics are currently running at Yate West Gate Centre, Cossham and Concord Medical Centre.
- Residents are also able to access the specialist clinics running in Bristol and North Somerset if these are more convenient days or times.
- As the new service develops there will be some changes to South Gloucestershire clinic days and times as we seek to broaden availability across the week (the majority of clinics to date have all fallen on a Thursday).
- Once the new clinic times are confirmed the Yuno website (<u>https://yunosexualhealth.co.uk</u>) will be updated to provide information about all of specialist clinics within South Gloucestershire, which have been identified in line with population need
- As part of the future service developments there will be a mobile clinic offer which will support outreach and engagement with priority areas which may not have a suitable fixed clinical site.

## **Primary care commissioned services**



All GP practices are required to provide a minimum level of sexual health services as part of their contract with the ICB.

In addition to the Yuno service, we also commission GPs and Pharmacies to deliver some sexual health provision in South Gloucestershire.

#### GPs are able to opt in to deliver:

- Long Acting Reversible Contraception (implants and coils)
- Chlamydia and Gonorrhoea screening

#### Pharmacies are able to opt in to deliver:

• Emergency Hormonal Contraception and Chlamydia and Gonorrhoea screening

#### **Next steps**



- Continue to work with UHBW to develop the South Gloucestershire specialist clinic timetable. It is anticipated that new clinic days and times will be implemented by July 2025 with the additional pop-up outreach provision available towards the end of the year
- Ongoing promotion of the YUNO service, both on our social media and webpages, but also working with local organisations to ensure that everyone is aware of the changes to the service and how to access it.
- Monitoring service utilisation and national sexual health and reproductive health indicators:
  - Chlamydia detection rate
  - New STI diagnoses
  - $_{\odot}$  HIV late diagnosis
  - $\circ$  Prescribed LARC
  - $_{\odot}$  Under 18s conception rates

#### How to support



Improving outcomes in sexual health and promoting healthy relationships is key to the achievement of the priorities in the South Gloucestershire Council Plan. Poor outcomes directly correlate with inequalities experienced by people in areas of economic deprivation and by under-served populations.

#### **STI Prioritisation Framework**

 In October 2024, UKHSA released a new STI Prioritisation Framework. This framework provides an evidence-based approach to guide local organisations in planning and delivering sexual health services. It focuses on reducing adverse health outcomes and addressing health inequalities through principals centred on the situation, target groups, and interventions.

#### **Women's Health Strategy Priorities for 2024**

- Expanding women's health hubs
