1. Introduction and Background

1.1 Introduction

This report presents the findings of the English Indices of Deprivation 2019 (ID 2019) for South Gloucestershire.

The ID 2019 is the Government's official measure of multiple deprivation at small area level.

The mapping of deprivation serves to emphasise the contrasting socio-economic conditions that are found within the district and throughout England. The indices will be used by Government to inform the targeting of regeneration resources and will provide evidence for identifying and monitoring areas of deprivation within the district.

The report firstly provides an overview of how the indices are constructed. It then looks at how the results should be interpreted before commenting on and mapping the results of each of the indices for South Gloucestershire at Lower Super Output Area (LSOA) level. Further commentary is then provided on the district level results.

1.2. Background

The Indices of Deprivation 2019 (ID 2019) has been commissioned by the Ministry of Housing, Communities and Local Government (MHCLG) and produced by Oxford Consultants for Social Inclusion (OCSI). It updates previous Indices published in 2015, 2010, 2007 and 2004.

The new ID 2019 is based on the approach, structure and methodology used to create previous reports.

The ID 2019 identifies concentrations of deprivation, however it is important to remember that deprivation is experienced by individuals living in an area. Not all people living in a deprived area will be deprived and, similarly, not all deprived people live in deprived areas.

People may be counted as deprived in one or more of the domains depending on the number of types of deprivation that they experience.

2. Methodology

2.1. The domains

The ID 2019 provides a set of relative measures of deprivation for small areas (Lower Super Output Areas) based on seven different domains of deprivation. These domains are then combined to create an overall LSOA level Index of Multiple Deprivation (IMD).

The seven domains are:

- Income deprivation
- Employment deprivation
- · Health deprivation and disability
- Education, skills and training deprivation
- Crime deprivation
- Barriers to housing and services deprivation
- Living environment deprivation

There are also two supplementary indices within the income domain; income deprivation affecting children and income deprivation affecting older people.

The composite IMD describes the LSOA by combining information from all seven domains. The domains were combined in two stages; first the domain scores were ranked then transformed into an exponential distribution, then the domains were combined using the following weights:


2.2 The indicators

Each of the domains is based on a basket of indicators. As far as possible, each indicator is based on data from the most recent time point available; in practice most indicators in the ID 2019 relate to the tax year 2015/16. A list of the indicators is provided against each domain in section 4.

Figure 1. overleaf summarises the process by which the ID 2019 is created.

2.3 The geography (Lower Super Output Areas)

The ID 2019, like the previous ID reports is based on geographical areas called Lower Level Super Output Areas (LSOAs).

LSOAs are small areas designed to be of a similar population size with an average of approximately 1,500 residents or 650 households. There are currently 32,844 LSOAs in England and 165 in South Gloucestershire.

2.3.1 LSOA boundary changes (2011)

Following the 2011 Census LSOAs were revised and the number increased (from 32,482 in England /162 in South Gloucestershire). The majority of LSOA boundaries in South Gloucestershire remained unchanged, but because the number of geographical areas has changed nationally, caution should be taken when comparing ranks between the ID 2015 and previous ID's.


Three LSOAs in South Gloucestershire were affected by boundary changes following the 2011 Census.

- Former LSOA E01014997 (UWE Walscourt Farm Area) split into two new LSOAs: E010133331 and E010133333.
- Former LSOA E01014971 (Siston Hill area) split into two new LSOAs: E010133339 and E010133338.
- Former LSOA E01014970 (Emersons Green area) split into two new LSOAs: E010133336 and E01033334.

2.3.2 Ward Boundary Changes (2007)

Administrative ward boundary changes introduced in May 2007 and 2019 also affect the way in which data from the ID is presented.

Prior to May 2007 ward and LSOA boundaries were aligned and whole LSOAs were 'nested' within wards. This is no longer the case. In many instances the latest ward boundaries intersect LSOAs, resulting in an LSOA being split between two (or more) wards as illustrated below:

Red line --- Ward boundary

Appendix B shows the location of LSOAs within each of South Gloucestershire's 28 wards.

Most tables in this report therefore include a 'ward reference column'. Where the LSOA is split between wards the proportion of the LSOA in each of the constituent wards is listed. For example LSOA E01014926 is split between three wards:

- Kingswood Ward 6%
- Woodstock Ward 58%
- New Cheltenham Ward 36%

3. Interpreting the results

3.1 Published data for Lower Super Output Areas

As outlined above, every LSOA in England (32,844) has been assigned a score and a rank for the Index of Multiple Deprivation (IMD) and the composite domains.

The most deprived LSOA is given a rank of 1, and the least deprived a rank of 32,844. The ranks show how an LSOA compares to all other LSOAs in the country and are easily interpretable. However the scores indicate the distances between each rank, as these will vary.

The scores for the income and employment domains are rates. So, for example, if an LSOA scores 38.6 in the income domain, this means that 38.6% of the LSOAs population is income deprived. The same applies to the employment domain, the income deprivation affecting children and income deprivation affecting older people sub-domains. The scores for the remaining domains are not rates. Within a domain the higher the score, the more deprived an LSOA is. However, the scores should not be compared between domains as they have different minimum and maximum values, and ranges. To compare between domains the ranks should be used.

3.2 Data time point

As far as is possible, each indicator was based on data from the most recent time point available. Using the latest available data in this way means that there is not a single consistent time point for all indicators. However in practice most indicators in the ID2019 relate to the tax year 2015/16. As with previous Indices, the ID 2019 only uses census data when alternative data from administrative sources is not available.

As a result of the time points for which data is available, the indicators do not take into account changes to policy since the time point the data is used.

3.3 Comparison with previous Indices of Deprivation

The purpose of the Indices is to measure as accurately as possible the relative distribution of deprivation at a small area level and this comes at the expense of backwards comparability with previous versions of the indices. The versions of the indices should not be construed as a time-series due to:

 Changes to the data used to construct the indicators, including changes to eligibility criteria for certain benefits used to measure

- income deprivation and employment deprivation
- Revisions to the population denominator data
- Changes to LSOA boundaries: Significant caution should be exercised when comparing ranks for ID2015 with previous updates, since there were 32,844 LSOAs at the time of the ID2015 compared with 32,482 for previous updates.

Given these differences, caution should be exercised when making comparisons between the ID 2019 and previous indices. It would be valid to state that an area showed an increased level of deprivation relative to other areas if it was ranked in the most deprived 20% of areas nationally based on the 2015 indices but ranked within the most deprived 10% according to the ID2019. However, it would not necessarily be correct to state that the level of deprivation in the area had increased on some absolute scale, as it may be the case that all areas had improved, but that this area had improved more slowly than other areas and so been 'overtaken' by those areas. Similarly, the overall rank of an area may not have changed between ID2019 and ID2015, but this does not mean that there have been no changes to the level of deprivation in the area.

In summary any comparison between ID2019 and previous Indices should be exercised with caution.

3.4 Deprivation Quintiles

Tables, graphs and maps in this report refer to 'deprivation quintiles'. Quintiles are fifths, the 1st quintile being the most deprived fifth (or 20%) and the 5th quintile being the least deprived fifth (or 20%).

In this report deprivation quintiles are used to show how LSOAs relate to others within a defined area. Maps and tables in this report use the following schema:



4. LSOA level summary analysis for South Gloucestershire

Table 1 (pages 5-13) illustrates the relative position of LSOAs in South Gloucestershire for each domain of the ID 2019.

How the information is presented

For each of the domains, data for South Gloucestershire has been ranked 1 to 165. A rank of 1 has been given to the most deprived LSOA and a rank of 165 given to the least deprived LSOA.

The cells have then been colour coded to represent the position of the LSOA in a national (England) context as outlined in section 3.4.

In simple terms rows of red indicate areas which are deprived across a range of indicators whilst green rows indicate less deprived areas.

Key facts about South Gloucestershire

- The results reinforce previously identified patterns of deprivation across the district. South Gloucestershire's most deprived areas are generally areas with high concentrations of former local authority housing estates.
- E01014977 the Pendennis Road area of Staple Hill & Mangotsfield is South Gloucestershire's most deprived LSOA in four of the eight domains (compared to 4 in 2015 and 5 in 2010). It is South Gloucestershire's most deprived LSOA in Income terms of the IMD, deprivation, Employment deprivation, and Health & disability deprivation. Nationally it is the 4.858 most deprived LSOA. This LSOA features in the most deprived national quintile (most deprived 20% of LSOAs in England) in five of the eight domains.
- E01014926 the New Cheltenham Road area of Kings Chase ward is the second most deprived LSOA in three of the eight domains (IMD, Income and Employment). It features in the most deprived national deprivation quintile in five domains; the IMD, Income deprivation, Employment deprivation, Education skills and training, and Crime. In 2015, this area featured in the most deprived quintile in three domains (income, employment and education), implying this area has become relatively more deprived.
- There are 46 LSOAs that feature within the 20% most deprived areas nationally in at least one domain. In 2015, 39 LSOAs featured within the 20% most deprived areas nationally in at least one domain, in 2010 there were 40, in 2007 there were 26 and in 2004 there were 21.

- Barriers to housing and services is the domain with the highest number of South Gloucestershire LSOAs in the most deprived 20% nationally (24 LSOAs).
- There are no LSOAs in South Gloucestershire in the most deprived 20% nationally for health deprivation.
- 101 LSOAs in South Gloucestershire are in the least deprived 20% nationally for living environment deprivation, making this the domain with the most LSOAs falling into the fifth quintile.
- E01014878 Brook way area of Bradley Stoke North is the only LSOA to feature in the least deprived 20% of all eight domains.

Chart 1 shows the minimum and maximum national ranking for the LSOAs in South Gloucestershire in each of the domains. The chart enables comparison between the domains and shows where South Gloucestershire's most and least deprived LSOAs are on a national scale. It also shows which domains have the widest and narrowest range of results. A long line indicates more variation in levels of deprivation than a short line.

- South Gloucestershire's lowest ranking LSOA in England is within the barriers to housing and services domain, the area is ranked 725th nationally (E01014891 – the Tormarton and surrounding rural area).
- South Gloucestershire's highest ranking LSOA in England is within the living environment domain, ranked 32,770th nationally (E01033331 – MoD / Walscourt Farm / UWE west area).

 The widest range of LSOA ranks is illustrated in the living environment domain; a difference of 31,867 places between the most and least deprived LSOAs.

Table 2 overleaf shows the most and least deprived LSOAs in South Gloucestershire for each of the domains.

Charts 2 to 9 on page 16 show the distribution of LSOAs in South Gloucestershire in terms of national deprivation quintiles for each of the eight domains. In most domains the majority of LSOAs fall within the least deprived quintiles (Q4 and Q5), with the exception of the education, skills and training domain, the crime domain and, the barriers to housing services domain.

Overall the split of quintiles for each domain follows the same trends in 2019 as it did in 2015. However, the barriers to housing and social services domain has seen a notable increase in the number of LSOAs falling into Q3 (30 in 2015 to 42 in 2019), and a decrease in the LSOAs in Q5 (48 in 2015 to 35 in 2019). The living environment domain has seen an increase in the number of LSOAs falling into the least deprived domain (Q5), rising from 76 in 2015 to 101 in 2019.

Chart 1. Range of ranks











Charts 2-9. Distribution of LSOAs in South Glos. in terms of national deprivation quintiles, 2019




















5. LSOA level analysis for South Gloucestershire by domain

5.1 Index of Multiple Deprivation (IMD)

Some facts about South Gloucestershire in this domain

- South Gloucestershire's most deprived LSOA remains E01014977, the Pendennis Road area of Staple Hill & Mangotsfield ward (ranked 4,858 nationally).
- Two LSOAs feature in the most deprived 20% of LSOAs nationally for the IMD domain one more than in same 2015 and 2010 (E01014977 Pendennis Road area and E01014926 New Cheltenham Road area).
- Nineteen (11.5%) of LSOAs fall within the most deprived 20-40% of areas in England, compared to eighteen (11%) in 2015.
- In terms of the composite IMD, the spread of LSOAs by national quintile has remained largely unchanged since ID2015. Chart 10 illustrates how the proportion of LSOAs has shifted slightly, from being mostly in the least deprived quintile in 2004 to a more even spread of LSOAs in national quintiles 2 to 4.
- South Gloucestershire's least deprived LSOA is E01014878 Brook way area in Bradley Stoke North. It is ranked 32,711st nationally which means it is the 133rd least deprived area in England.

Changes between ID2015 and ID2019

As noted previously caution should be taken when comparing results of the ID2019 with previous indices. Tables 4 and 5 indicate the LSOAs which have become more and less deprived to the greatest extent since 2015:

- E01014864 Alveston/ Rudgeway / Earthcott Green area is the LSOA which has become more deprived to the greatest extent (falling 8,011 places since 2015).
- In contrast, E01014910 the Filton college area, is the LSOA which has become less deprived to the greatest extent (rising 5,217 places since 2015).

Map 1. English Indices of Deprivation 2019 – Index of Multiple Deprivation (IMD)



5.2 Income Deprivation Domain

This domain measures the proportion of the population in an area that live in income deprived families. The definition of income deprivation adopted here includes both families that are out-of-work and families that are in work but who have low earnings (and who satisfy the respective means tests).

The indicators

- Adults and children in Income Support families
- · Adults and children in income-based Jobseeker's Allowance families
- Adults and children in income-based Employment and Support Allowance families
- · Adults and children in Pension Credit (Guarantee) families
- Adults and children in Child Tax Credit and Working Tax Credit families, below 60% median income not already counted
- Asylum seekers in England in receipt of subsistence support, accommodation support, or both
- Adults and children in Universal Credit families where no adult is in 'Working no requirements' conditionality regime*

Some facts about South Gloucestershire in this domain...

- E01014977, the Pendennis Road area of Staple Hill is South Gloucestershire's most deprived area ranked 4,720 nationally. This LSOA was also the most deprived area for income in 2015. 23.6% of the population of this LSOA are income deprived. The data indicates that this area has become relatively less deprived since 2015 (rising from a national rank position of 3,783 / 28.9%).
- There are two LSOAs in South Gloucestershire which feature in the 20% most deprived LSOAs in England for this domain. These are E01014977 (as noted above) and E01014926 the New Cheltenham Road area in Kingswood priority neighbourhood (ranked 6,034 nationally). This is consistent with the findings of the ID2015.
- Across South Gloucestershire as a whole there are 19,953 residents who are 'income deprived'. This compares to 23,027 in 2015.
- LSOA E01014887 St Johns Way area, ranked 32,495 nationally, is the least deprived LSOA in South Gloucestershire.
- Chart 11 shows that the results are broadly consistent with those of previous indices.

LSOA level changes between ID2015 and ID2019

As noted previously, caution should be taken when comparing results of the ID2019 with previous indices. Tables 7 and 8 indicate the LSOAs which have become more and less deprived since 2015 to the greatest extent:

- E01014921 the Hanham Green area is the LSOA which has become most deprived to the greatest extent - falling one national quintile from Q4-Q3 (8,152 rank places since 2015).
- In contrast, E01015010 the Brookthorpe / Longford area, is the LSOA which has become less deprived to the greatest extent (rising 6,321 places since 2015).

Further analysis of the underlying data and / or local proxy measures would be necessary to ascertain whether these changes are 'real'.

Map 3. English Indices of Deprivation 2019 – Income Deprivation Domain







Chart 11. Change in distribution of LSOAs by national quintiles (2004-2019)

5.3 Employment Deprivation Domain

This domain measures employment deprivation conceptualised as involuntary exclusion of the working age population from the world of work. The employment deprived are defined as those who would like to work but are unable to do so through unemployment, sickness or disability, or caring responsibilities.

The Indicators

- Claimants of Jobseeker's Allowance, aged 18-59/64
- Claimants of Employment and Support Allowance, aged 18-59/64
- Claimants of Incapacity Benefit, aged 18-59/64
- Claimants of Severe Disablement Allowance, aged 18-59/64
- Claimants of Carer's Allowance, aged 18-59/64
- Claimants of Universal Credit in the 'Searching for work' and 'No work requirements' conditionality groups*

Some facts about South Gloucestershire in this domain...

- LSOA E01014977, the Pendennis Road area of Staple Hill & Mangotsfield ward is South Gloucestershire's most deprived area in terms of this domain. The area has become less deprived since 2015 rising in national rank position from 3,154 to 4,280. This LSOA is now in the 2nd national decile (the most deprived 20% of LSOAs in England).
- Four LSOAs appear within the 20% most deprived areas in England, the same number as in 2015. The LSOAs are: E01014977 (as discussed above); E01014926 – the New Cheltenham Road area of Woodstock ward; E01014948 – the Coniston North area of Patchway Coniston ward and E01014976 -Upper Soundwell area of Staple Hill and Mangotsfield ward.
- There are 25 LSOAs where more than one in ten residents (10%) are 'employment deprived'. This compares to 38 in 2015. Across South Gloucestershire as a whole, there are 9,765 residents who are 'employment deprived' compared to 11,416 in 2015.
- For this domain, 37% of LSOAs in South Gloucestershire (61) are within the 20% least deprived areas in England. This compares to 38% (63) in 2015.
- In terms of employment deprivation, South Gloucestershire's least deprived LSOA is E01033333 – UWE east / Hambrook area (ranked 32,134 nationally).
- Chart 1 shows that the split by quintile of this domain is broadly consistent with those reported in previous years but the percentage of LSOAs in the least deprived quintile (Q5)

has decreased slightly and the total in Q2 (most deprived 20-40%) has increased slightly since 2004.

LSOA level changes between ID2015 and ID2019

As noted previously, caution should be taken when comparing results of the ID2019 with previous indices. Tables 10 and 11 indicate the LSOAs which have become more and less deprived since 2015 to the greatest extent:

- E01014961 the Burley Grove / Gerrish avenue area of Staple Hill and Mangotsfield ward is the LSOA that has experienced the biggest increase in deprivation - falling one national quintile from Q3 to Q2 (-5,159 rank places since 2015).
- E01014913 the Woodend road / Beesmoore road area of Frampton Cotterell ward is the LSOA that has experienced the biggest decrease in deprivation – rising one national quintile and 4,538 rank places since 2015.

Further analysis of the underlying data and / or local proxy measures would be necessary to ascertain whether these changes are 'real'.

Map 5. English Indices of Deprivation 2019 – Employment Deprivation Domain







Chart 12. Change in distribution of LSOAs by national quintiles (2004-2019)

5.4 Health Deprivation and Disability Domain

This domain measures premature death and the impairment of quality of life by poor health. It considers both physical and mental health. The domain measures morbidity, disability and premature mortality but not aspects of behaviour or environment that may be predictive of future health deprivation.

The indicators

- Years of potential life lost: An age and sex standardised measure of premature death
- Comparative illness and disability ratio: An age and sex standardised morbidity/disability ratio
- Acute morbidity: An age and sex standardised rate of emergency admission to hospital
- Mood and anxiety disorders: A composite based on the rate of adults suffering from mood and anxiety disorders, hospital episodes data, suicide mortality data and health benefits data.

Some facts about South Gloucestershire in this domain...

- This is the domain in which South Gloucestershire has the least LSOAs in the most deprived 20% nationally with no LSOAs falling within the first national quintile.
- LSOA E01014977 the Pendennis Road area of Staple Hill is South Gloucestershire's most deprived LSOA in terms of this domain (ranked 9,537 nationally). This area is in the second most deprived quintile nationally.
- Two other LSOAs feature in the second national quintile (the 20-40% most deprived areas nationally): E01014924 and E01014946.
 In comparison there were five LSOAs in this quintile in 2015.
- 53% (88) of South Gloucestershire's LSOAs are within the 20% least deprived LSOAs in England, slightly fewer than in 2015 - 55% (91).
- LSOA E01014862 Almondsbury area to Gaunt's Earthcott (Severn ward) is South Gloucestershire's least deprived LSOA in terms of this domain. This area is ranked 32,516 nationally.
- The results of this domain by quintile are broadly consistent with those reported in previous indices. Chart 13 however illustrates changes since 2004.

LSOA level changes between ID2015 and ID2019

As noted previously, caution should be taken when comparing results of the ID2019 with previous indices. Tables 13 and 14 indicate the LSOAs which have become more and less deprived since 2015 to the greatest extent:

- LSOA E01014924 Downend Road / Worcester Road area of Kingswood is the LSOA which has become relatively more deprived to the greatest extent, falling -6,232 rank places (one national quintile position) between 2015 and 2019.
- E01014910 The Filton College area in Filton ward is the LSOA in this domain which has seen the greatest decrease in deprivation since 2015, rising one national quintile position from 4 to 5. It has risen 8,761 rank places.

Further analysis of the underlying data and / or local proxy measures would be necessary to ascertain whether these changes are 'real'.

Map 7. English Indices of Deprivation 2019 – Health Deprivation Domain







Chart 13. Change in distribution of LSOAs by national quintiles (2004-2019)

5.5 Education, Skills and Training Deprivation Domain

This domain captures the extent of deprivation in education, skills and training in an area. The indicators fall into two sub-domains: one relating to children and young people and one relating to adult skills. These two sub-domains are designed to reflect the 'flow' and 'stock' of educational disadvantage within an area respectively. That is, the 'children and young people' sub-domain measures the attainment of qualifications and associated measures ('flow'), while the 'skills' sub-domain measures the lack of qualifications in the resident working age adult population ('stock').

The indicators

Children and Young People sub-domain

- Key Stage 2 attainment: scaled score
- Key Stage 4 attainment: The average capped points score of pupils taking Key Stage 4
- Secondary school absence: The proportion of authorised and unauthorised absences from secondary school
- Staying on in education post 16: The proportion of young people not staying on in school or nonadvanced education above age 16
- Entry to higher education: A measure of young people aged under 21 not entering higher education.

Adult Skills sub-domain

- Adults with no or low qualifications, aged 25-59/64
- Adults who cannot speak English or cannot speak English well, aged 25-59/64

Some facts about South Gloucestershire in this domain...

- E01015020 Milton Road / Birch Road area of Yate North / Yate Central Ward is South Gloucestershire's most deprived area in terms of this domain. The area is ranked 1,833rd nationally which places it within the 1st quintile.
- There are 18 LSOAs within the first national quintile (most deprived 20% of areas in England) three more than in 2015 (15).
- There are 6 LSOAs within the first national decile (most deprived 10% of areas in England)
 compared to 4 in 2015 and none in 2010.
- E01014985 The Primrose Drive / Squires Lease area of Thornbury is South Gloucestershire's least deprived LSOA, ranked 31,773rd nationally.

LSOA level changes between ID2015 and ID2019

As noted previously, caution should be taken when comparing results of the ID2019 with previous indices. Tables 16 and 17 indicate the LSOAs which have become more and less deprived since 2015 to the greatest extent:

- E01014916 Martins Road / Ansteys Road area (Hanham Ward) is the area that has become relatively more deprived to the greatest extent, falling 6,621 rank places between 2015 and 2019 (down one national quintile position).
- E01015009 Sunridge Park area of Yate Central / Dodington wards is the area that has become relatively less deprived to the greatest extent, rising 6,949 rank places since 2015 and one national quintile position.

Further analysis of the underlying data and / or local proxy measures would be necessary to ascertain whether these changes are 'real'.

Map 9. English Indices of Deprivation 2019 – Education, Skills and Training Deprivation Domain








Chart 14. Change in distribution of LSOAs by national quintiles (2004-2019)

5.6 Barriers to Housing and Services Domain

This domain measures the physical and financial accessibility of housing and key local services. The indicators fall into two sub-domains: 'geographical barriers', which relate to the physical proximity of local services, and 'wider barriers' which includes issues relating to access to housing such as affordability.

The indicators

Geographical Barriers sub-domain

- Road distance to a post office
- Road distance to a primary school
- Road distance to a general store or supermarket
- Road distance to a GP surgery.

Wider Barriers sub-domain

- Household overcrowding: The proportion of all households in a LSOA which are judged to have insufficient space to meet the household's needs
- Homelessness: Local authority district level rate of acceptances for housing assistance under the homelessness provisions of the 1996 Housing Act, assigned to the constituent LSOA
- Housing affordability: Difficulty of access to owner-occupation or the private rental market, expressed as the inability to afford to enter owner occupation or the private rental market.

Some facts about South Gloucestershire in this domain...

- This is the domain in which South Gloucestershire is most deprived: 24 LSOAs (15%) feature within the most deprived national quintile - seven more than in 2015.
- LSOA E01014891 Tormarton and surrounding rural area is South Gloucestershire's most deprived LSOA in terms of this domain. The area is ranked 725th nationally and has become relatively more deprived since 2015 (down 129 rank positions).
- Seven LSOAs are within the 10% most deprived areas in England: E01014891 (as outlined above), E01014962 (Oldbury on Severn rural area), E01014861 (Easter Compton / Cribbs Causeway area), E01014870 (Doynton / Dyrham rural area), E01014989 (Falfield / Whitfield / Morton area), E01014864 (Alveston / Rudgeway / Earthcott Green area) and E01033333 (UWE east / Hambrook area).
- The highest rates of deprivation in this domain are generally found in rural areas due to the road distances to services and higher average house prices.
- South Gloucestershire's least deprived LSOA in terms of this domain is E01014912 – the Area surrounding Highcroft Junior School (Frampton Cotterell Ward), which is ranked 32,329th nationally.

LSOA level changes between ID2015 and ID2019

As noted previously, caution should be taken when comparing results of the ID2019 with previous indices. Tables 19 and 20 indicate the LSOAs which have become more and less deprived since 2015 to the greatest extent:

- E01014863 the Area around St Helens CofE Primary Schoola of Severn Vale Ward is the area which has become relatively more deprived to the greatest extent falling 18,856 rank places (three national quintiles) between 2015 and 2019. Further analysis of the underlying data would be necessary to ascertain whether these changes are in fact 'real'.
- E01014866 the Cherry Garden primary school area of Longwell Green / Bitton & Oldland Common wards is the LSOA which has seen the greatest decrease in deprivation between 2015 and 2019 for this domain, rising 17,886 rank places (two national quintile positions).

Further analysis of the underlying data and / or local proxy measures would be necessary to ascertain whether these changes are 'real'.

Map 11 - English Indices of Deprivation 2019 - Barriers to Housing and Services Domain



5.7 Crime Domain

Crime is an important feature of deprivation that has major effects on individuals and communities. The purpose of this domain is to measure the rate of recorded crime for four major crime types – violence, burglary, theft and criminal damage – representing the risk of personal and material victimisation at a small area level.

The indicators

- Violence number of reported violent crimes (18 reported crime types) per 1000 at risk population
- Burglary number of reported burglaries (4 reported crime types) per 1000 at risk population
- Theft number of reported thefts (5 reported crime types) per 1000 at risk population
- Criminal damage number of reported crimes (8 reported crime types) per 1000 at risk population.

Some facts about South Gloucestershire in this domain...

- LSOA E01015007, which covers the Holy Trinity Church / Orchard Road / Cecil Road area of Kingswood / Woodstock wards remains South Gloucestershire's most deprived area in terms of this domain. The LSOA is ranked 1,392nd nationally which means it is within the most deprived 5% of areas in England. The area has become slightly less deprived since 2015 where it was the 1,063rd most deprived LSOA nationally (within the 3% most deprived areas in England).
- In 2010 this was the domain in which South Gloucestershire was most deprived - with 21 LSOAs falling within the most deprived 20% of areas in England. In 2015 this number was significantly reduced to just six. In 2019 there is a slight increase in the number of LSOAs within the most deprived 20% nationally, with 10 LSOAs in the first quintile.
- South Gloucestershire's most deprived areas in terms of this domain tend to be focussed in urban wards around the East Fringe of Bristol.
- 34 (21%) of South Gloucestershire's LSOAs are within the 20% least deprived areas nationally, slightly less than in 2015 (41 LSOAs / 25%).
- South Gloucestershire's least deprived LSOA in terms of this domain is E01014879 – Ash Ridge Road /Eagles Wood Business Park area, ranked 32,444 nationally.

LSOA level changes between ID2015 and ID2019

As noted previously, caution should be taken when comparing results of the ID2019 with previous indices. Tables 22 and 23 indicate the LSOAs which have become more and less deprived since 2015 to the greatest extent:

- LSOA E01033338 Siston / Siston Hill area has undergone a considerable increase in relative deprivation of -12,380 national rank places since 2015 (a decrease of two national quintiles).
- LSOA E01014939 Warmley CofE Primary and Warmley Tower area, has undergone a considerable reduction in relative deprivation of +10,458 national rank places since 2015 (an increase of two national quintile positions).

Further analysis of the underlying data and / or local proxy measures would be necessary to ascertain whether these changes are in fact 'real'.

Map 13. English Indices of Deprivation 2019 – Crime Deprivation Domain







Chart 16. Change in distribution of LSOAs by national quintiles (2004-2019)

5.8 Living Environment Deprivation Domain

This domain measures the quality of individuals' immediate surroundings both within and outside the home. The indicators fall into two sub-domains: the 'indoors' living environment, which measures the quality of housing, and the 'outdoors' living environment which contains two measures relating to air quality and road traffic accidents.

The indicators

Indoors sub-domain

- Houses without central heating: The proportion of houses that do not have central heating
- Housing in poor condition: The proportion of social and private homes that fail to meet the Decent Homes standard.

Outdoors sub-domain

- Air quality: A measure of air quality based on emissions rates for four pollutants
- Road traffic accidents involving injury to pedestrians and cyclists: A measure of road traffic accidents involving injury to pedestrians and cyclists among the resident and workplace population.

Some facts about South Gloucestershire in this domain...

E01014891 - Tormarton and surrounding rural area (Boyd Valley / Chipping Sodbury ward) is South Gloucestershire's most deprived area in terms of this domain. The LSOA is ranked 903rd nationally, a considerable drop since 2015 when it was ranked 3,497th.

- There are six LSOAs within the most deprived 20% of areas in England: E01014891 (as outlined above); E01014989 - Falfield/ Whitfield/Morton area; E01014870 - Doynton /Dyrham rural area; E01014962 - Oldbury on Severn rural area; E01014890 - Area surrounding Horton/Hawkesbury Upton and E01014929 - Rangeworthy and Iron Acton rural area.
- The majority of South Gloucestershire's LSOAs are within the least deprived 20% of areas nationally for this domain (61% / 101 LSOAs). This is an increase on the 2015 figure in which 76 (46%) of LSOAs were in the fifth quintile. This suggests South Gloucestershire has become relatively less deprived in this domain.
- E01033331- MoD / Walscourt Farm / UWE west area of Stoke Park & Cheswick ward is South Gloucestershire's least deprived LSOA. The area is ranked 32,770 nationally.
- Chart 17 shows that there are significantly more LSOAs falling into the least deprived 20% (Q5) than in 2015. The percentage of LSOAs in Q4 and Q3 has declined slightly with the trends for Q1 and Q2 remaining broadly consistent.

LSOA level changes between ID2015 and ID2019

As noted previously, caution should be taken when comparing results of the ID2019 with previous indices. Tables 25 and 26 indicate the LSOAs which have become more and less deprived since 2015 to the greatest extent:

- E01014870 Doynton / Dyrham rural area of Boyd Valley ward has become more deprived to the greatest extent, falling 5,688 rank positions since 2015 (a decrease of one national quintile position).
- LSOA E01014872 Great Meadow Road / Palmers Leaze area of Bradley Stoke South ward, has undergone a considerable reduction in relative deprivation of +13,235 national rank places since 2015 (an increase of two national quintile positions).

Further analysis of the underlying data and / or local proxy measures would be necessary to ascertain whether these changes are 'real'.

Map 15. English Indices of Deprivation 2019 – Living Environment Deprivation Domain







Chart 17. Change in distribution of LSOAs by national quintiles (2004-2019)

6. District Level Analysis

6.1 Introduction

The ID 2019 provides local authority district level results which enable direct comparison between local authorities in England.

Local Authority districts are complex to describe as a whole or to compare for several reasons. Firstly, districts can vary enormously in population size. Furthermore, some districts may have a more mixed population, containing more variation in deprivation and in some places deprivation may be concentrated in severe pockets rather than being more evenly spread. This makes an overall picture more difficult to establish. For a more detailed or subtle description of deprivation across a district the LSOA results should be used as the LSOA level Index of Multiple Deprivation contains the most detailed account of local deprivation. At the LSOA level much more information is retained than with the district level summaries.

At the district level, six measures have been devised which take account of these issues and which describe the district in different ways. The measures are:

Average of LSOA Ranks

Population weighted average of the combined ranks for the LSOAs in a district.

Average of LSOA Scores

Population weighted average of the combined scores for the LSOAs in a district.

Extent

The proportion of the population living in LSOAs which rank within the most deprived LSOAs in England. This measure aims to show how widespread high levels of deprivation are in a district.

Local Concentration

The population weighted average of the ranks of a district's most deprived LSOAs that contain exactly 10% of the district's population. This measure is used to show 'hot spots' of deprivation.

Income Scale

The proportion of the population within the district experiencing deprivation relating to low income.

Employment Scale

The proportion of the working age population within the district experiencing employment deprivation.

There are 317 local authority districts in England. For each measure, each district is given a rank and score. For presentation, a rank of 1 indicates that the district is the most deprived according to the measure and 317 is the least deprived. Please note that previous ID reports have been ranked out of 326 local authority districts and ranks are therefore not directly comparable.

Table 27 shows the district level results for South Gloucestershire for the ID 2019 compared to those from previous indices.

Tables 28-33 show the 10 most deprived local authorities in England for each of the 6 district measures of deprivation.

6.2. Average of LSOA Ranks

This measure summarises the district as a whole by averaging all the LSOA <u>ranks</u> in each district. LSOA ranks are population weighted within a district to take account of differing LSOA populations.

Table 29 shows the 10 most deprived local authorities in England in terms of this indicator.

- South Gloucestershire is the 267th most deprived district in England (out of 317) in terms of this measure. This places the authority in the least deprived 20% in England, as it was in the ID2015 as well.
- Blackpool is the most deprived local authority nationally, Hart (Hampshire) is the least deprived.

6.3 Average of LSOA Scores

This is the population weighted average of the combined scores for all LSOAs in the district. LSOA scores covers the whole area including deprived and non-deprived areas (same as rank above) but also takes into account 'extreme' scores i.e. particularly deprived or un-deprived areas, which are concealed if the ranks are used.

Table 28 shows the 10 most deprived local authorities in England in terms of this indicator.

- South Gloucestershire is the 269th most deprived local authority in England (out of 317). The authority is in the 5th national deprivation quintile, which means it is one of the 20% least deprived districts in England. South Gloucestershire was also in Q5 in 2015.
- Blackpool is the most deprived district nationally, Hart (Hampshire) is the least deprived.

6.4 Extent

This measure shows how widespread high levels of deprivation are in a district. It measures the proportion of a district's population living in the most deprived 30 per cent of LSOAs in the country (a proportion of the population in the next most deprived areas is also taken into account). The extent measure is a more sophisticated version of the proportion of LSOAs in the most deprived 10 per cent nationally measure, and is designed to avoid the sharp cut-off seen in that measure, whereby areas ranked only a single place outside the most deprived 10 per cent are not counted at all.

Table 30 shows the 10 most deprived districts in England in terms of this indicator.

- South Gloucestershire is ranked 261st nationally (out of 317). 1.2% of its population live within the most deprived LSOAs in the country.
- Liverpool is the most deprived district nationally, 62% of its population live in the most deprived LSOAs in England.

6.5 Local Concentration

This measure helps identify districts 'hot spots' of deprivation. Local concentration is the population weighted average of the ranks of a districts most deprived LSOAs that contain exactly 10% of the districts population.

Table 31 shows the 10 most deprived local authorities in England in terms of this indicator.

South Gloucestershire is ranked 254th nationally which means it is in the 5th national quintile or within the 20% least deprived local authorities in England for this measure.

 Blackpool is the most deprived local authority in England in terms of this indicator, The Isles of Scilly is the least deprived.

6.6 Income Scale

This measures the proportion of the population within the district experiencing deprivation relating to low income.

Table 32 shows the 10 most deprived districts in England in terms of this indicator.

 19,953 people in South Gloucestershire are 'income deprived' (decreasing from 23,027 in 2015). South Gloucestershire is ranked 115th nationally.

6.7 Employment Scale

This measures the proportion of the working age population within the district experiencing employment deprivation.

Table 33 shows the 10 most deprived districts in England in terms of this indicator.

- In South Gloucestershire 9,765 people are 'employment deprived'. South Gloucestershire is ranked 110th nationally.
- Birmingham is the most deprived district nationally and Isles of Scilly is least deprived.

7. Conclusions

The ID 2019 is the most detailed study of deprivation in England to date.

In general terms South Gloucestershire remains relatively un-deprived. However it does have some sub-ward level 'pockets of deprivation' in some domains that feature on a national scale.

The results provide statistical evidence supporting the perception that there are some small areas of South Gloucestershire which are considerably more deprived than others.

Whilst there are certain parts of the district where there is a greater concentration of deprivation, residents experiencing deprivation can be found in all geographical areas and policy should not ignore these individuals and households.


Appendix Aii - Changes to LSOA Boundaries following 2011 Census

Three (2004) LSOA boundaries were split in 2011 to create six new LSOAs. These changes are limited to areas in UWE / Walscourt Farm, Siston Hill and Emersons Green – which have experienced high levels of residential development over the last decade. There are now 165 LSOAs in South Gloucestershire.

The following maps illustrate the changes. Red lines on the maps illustrate former (2004) LSOA boundaries, the blue lines illustrate the new LSOA boundaries.


