

 - Inspect agendas, reports and minutes of the Council and all Committees and

Sub-Committees for up to six years following a meeting.

- Inspect background papers used to prepare public reports for a period of up to four years from the date of the meeting. (A list of background papers to a report is given at the end of each report). A background paper is a document on which the officer has relied in writing the report.
- Have access to the public register of names, addresses and wards of all Councillors with details of the membership of all Committees and Sub-Committees.
- Have a reasonable number of copies of agendas and reports (relating to items to be considered in public) made available to the public attending meetings of the Council, Committees and Sub-Committees.
- Have access to a list setting out the decision making powers the Council has delegated to their officers and the title of those officers.
- Copy any of the documents mentioned above to which you have a right of access. There is a charge of 15p for each side of A4, subject to a minimum charge of £4.

WELCOME AND INTRODUCTIONS

Attendees were welcomed by the Chair.

APOLOGIES FOR ABSENCE

1. **DECLARATIONS OF INTEREST - None**

2. ANY OTHER ITEMS THE CHAIR DECIDES ARE URGENT (Pippa Osborne)

Pippa, Dave Baker, Louise Leader and Diane Owen joined the Cabinet Members Briefing on 19th October where they met Cllr. Ian Boulton, Cabinet Member for Education, Skills, Employment and Business and Daniel Ward, Communications Officer and shared an extensive list of the impact and sacrifices schools have to make in order to balance the budgets

It was agreed some next steps would be about raising the profile with the broader public and to share with the press a bit more of that awareness of the challenges schools are facing and that headteachers and schools not feeling alone and to show closer working and building partnerships with headteachers and the LA.

Need to emphasise it is quite shocking and we must not paper over the cracks and everyone has to make cuts.

HS – There has been a challenge on the equalities agenda and how well our schools have improved in the recent years. The education outcomes are good overall but the gap between the disadvantaged and the rest is getting bigger.

Action: HS to do a piece of work with schools on how we can try and unpick this gap and how this compares with other LAs and the benefits they have especially with children of a disadvantage.

PO - English as an Additional Language (EAL) is another challenge and are often let down as we do not have the resources to have staff to support with the increasing numbers of children from Hong Kong and Ukraine.

Action: Pippa to send over the notes of the meeting and the list of sacrifices to add to the minutes.

3. MINUTES FROM LAST MEETING - 28th September 2023

Minutes recorded as accurate.

4. Setting the Schools Budget 2024-25 (Mustafa Salih)

Mustafa went through the report highlighting key areas on the ongoing transfer of the £2.2m from the schools block to the high needs block. There was a typo in paragraph one that 2023-24 should read 2024-2025.

Recommendation. Schools Forum to approve the following Option:

Option 1: a £2.2m transfer from the Schools Block to the High Needs Block, which continues the same level of transfer that had been secured for 2023-24 and allows the investments in Cluster Funding Early Help, Early Years, and EHCP processes to support the DSG Recovery Plan to continue.

We have to consult the Schools Forum and that view has to be considered by the Council in February next year as part of setting the Schools Budget 2024-25. We also provide the outcome of the consultation with the Schools Forum to the DfE. The Council does also need to obtain the Secretary of State for Education's approval for the £2.2m transfer and with that regard it is also important to point out that the £2.2m transfer is assumed in our Safety Valve agreement signed by the DfE.

Staying on track with the Safety Valve agreement and failure to maintain that progress could put at risk the £25.5m secured through the Safety Valve Programme.

DB – comment in chat. "Do we need to note in the minutes about Mustafa's 2024-25 budget report that there will be a grant from April 2024 to fund the 5.8% increase in employer contributions for teachers' pensions that was announced at the end of last week?"

In the 'chat' section. Extract of the briefing from David Jenkins for Governors audience:

"Yet, despite all the successes described above and despite the annual transfer of £2.2M from the Schools Block to the High Needs block over the last four years and an increase in funding from the DfE that South Glos benefitted comparatively better than other Local Authorities, the High Needs Block deficit remains stubbornly constant. An increase in demand was always assumed and accounted for, but it has risen by much more than was forecast. One area of need that has increased significantly and which is now much higher than the national average is SEMH, particularly in the secondary sector. An analysis of why there has been such a growth in SEMH need will be a priority focus in the new academic year."

Members unanimously approved Option 1 of agreeing to the £2.2m transfer for the next financial year 2024-25 with the understanding that a narrative would go with the approval and to make sure that it is not just to Members but also the Secretary of State (SoS) as well and we are assured that the SoS looks at all those requests for transfers. This effectively developed an option 2 as follows:

Option 2: a £2.2m transfer from the Schools Block to the High Needs Block, which continues the same level of transfer that had been secured for 2023-24 and allows the investments in Cluster Funding Early Help, Early Years, and EHCP processes to support the DSG Recovery Plan to continue in 2024/25 and a clear explanation of the pressures facing school budgets and the need for more Government funding to be added to the Disapplication Request and to the February Cabinet report .

Pippa as Chair to potentially draft a short paragraph to try and sum up the views of Schools Forum and have David Jenkins paragraph circulated and then hopefully Mustafa can go back to the Members and the SoS.

Pippa fully intends to sign this off from the members of Schools Forum and that encompasses all South Gloucestershire schools and academies.

Decision: The Forum unanimously approved Option 2 as set out above.

Action: To add Option 2 in the Minutes.

5. Schools in Financial Difficulty Update (Deb Luter)

Deb went through the Financial report that was sent to the Forum.

We are working much closer with the Schools Improvement team and Schools Admissions team and to help those schools in financial difficulty which is very well received by the schools.

MS – We are a Forum of maintained and academy schools and we can only do a report on maintained schools as we have no access or mandate for Academy school budgets. Would the Forum be in favour of trying to cover the Financial position of Academy schools as well as maintained schools in future reports like this?

Action: The Forum approved including Academies and Mustafa was asked to send an email out to the different CEOs of the different MATs with the data needed to give the Forum a wider picture of all schools in financial difficulty.

5. Dedicated Schools Grant 2023/24 Quarter 1 (Caroline Warren)

CW shared the report on the update of the Dedicated Schools Grant (DSG) and the Safety Valve position as at Quarter 1 2023/24.

PO – Action for HNWG on what the numbers are for pupils with EHCPs in mainstream but who should be in specialist provision but because a specialist place cannot be found they remain in mainstream with additional support funded. This can be a hidden cost, but also can be seen as a benefit.

Nicky Edwards who stepped down from the role of the Early Years representative on the Forum but is now back on the Forum as an Early Years Rep asked the question of why we can't plan to spend that Early Years Block underspend and wouldn't it be useful to spend it in this financial year.

Action: MS to review legality of this option and discuss with Nicky.

6. High Needs Working Group Update (Susie Weaver)

KG - Does the contingency include budget for those students with EHCPs who require specialist provision, but who currently remain in the mainstream sector?

Action: To be explored at the next HNWG meeting on the 29^{th of} November and also to explore investment in EYFS and report back to the Forum.

7. Schools Forum Forward Plan

Proposed financial amendments around breach funding to move to January 2024 (Caroline Warren).

NE-2-year early years funding coming in November for working parents and not December in which case if the DfE release the early years funding formula could we consider putting it on the forward plan earlier than normal?

HS – To take this forward as an action with Jo Briscombe who might bring a report to Schools Forum at the end of December/early January.
