### Your Information

This Privacy Information relates to the personal information we have collected from activities relating to 'general public consultations[1]' promoted via the Council's corporate consultation system – 'Inovem eConsult'.

Inovem eConsult is administered on behalf of South Gloucestershire Council by our partner Inovem Ltd. You do not need to register if you want to browse our consultations or to take part in the vast majority of them. However, you will need to register (by providing an email address) if you want to receive a regular email alerting you to current consultations run by South Gloucestershire Council, or partner agencies, based on the 'topics of interest' you have expressed an interest in.

Your email address (and any topic preferences) are personal information. As part of your registration you are required to create a password. This is so that you can access a 'My Profile' page on this website where you can change your email preferences, and also offers another way of unsubscribing from receiving the emails.

We have made sure we will use your information according to the UK Data Protection laws by establishing the condition of delivering a statutory service and permission being provided by the customer to use the information.

#### How we'll use your information

The information you provide will form part of your econsult registration. We only collect the minimum personal data required to provide your registration. The information is used for the performance of a task carried out in the public interest, as allowed under the General Data Protection Regulation Article 6 (1) (e).

We'll use your information to provide the above service you have requested whilst complying with the established lawful conditions.

We'll keep your information for as long as you have a relationship with us. We will hold the information you provide on the system until you unsubscribe. You can unsubscribe at any time by clicking the 'unsubscribe' link in:

- The regular emails you receive (based on your selected 'topics of interest'), or
- The 'My Profile' area of Inovem eConsult

Specific information relating to this service will be retained according to the relevant record retention schedule which can be found <u>here</u>. We may retain anonymised information about the service we provided to help us improve our services in the future.

## Transferring your information overseas

Your information is not transferred and stored in countries outside the UK or the European Economic Area (EEA) for the provision of this service.

## Your rights
