Summary of Key changes by title

Governor Skills – new section to align with Schools Financial Value Standard (SFVS)

Finance Committee or Equivalent – new section to algin with SFVS, suggested terms of reference

Financial Reporting – new section to align with SFVS

Related Party Transactions – added to reflect new requirements for RPTs.

Financial Expertise – new section to align with SFVS

Financial Strategy – new section to align with SFVS

Staffing Structure – new requirement to evidence vacancy approvals, better alignment to SFVS

Pensions- updates from Payroll Manager on latest requirements.

Scheme of Delegation and Authorisation Limits – clarification of requirements

Purchasing – addition of purchasing cards and updates to procurements arrangements post transition out of EU.

VAT – updates post transition out of EU and any other updates for VAT Accountant.

Commercial Activity & Additional Services – ceasing the requirement for maintained schools to submit a return to internal audit regarding their breakfast and after school clubs. Requirement for regular separate reporting to Governing Board.

Insurance – Clarification of the governments Risk Protection Arrangements for schools

Information Security – updates to reflect national cyber security council links and latest guidance.
