# **English Indices of Deprivation 2019** Sub domains of deprivation

## Introduction

This report presents the findings of the English Indices of Deprivation sub domains data for South Gloucestershire.

The six sub-domains, and their respective domains, are as follows:

- The **Barriers to Housing and Services Domain** measures the physical and financial accessibility of housing and local services. The indicators fall into two sub-domains: the **Geographical Barriers Sub-domain**, which relates to the physical proximity of local services, and the **Wider Barriers Sub-domain** which includes issues relating to access to housing such as affordability.
- The Living Environment Deprivation Domain measures the quality of the local environment. The indicators fall into two sub-domains. The Indoors Sub-domain measures the quality of housing; while the Outdoors Sub-domain contains measures of air quality and road traffic accidents.
- The Education, Skills and Training Deprivation Domain measures the lack of attainment and skills in the local population. The indicators fall into two sub-domains: one relating to children and young people and one relating to adult skills. These two sub-domains are designed to reflect the 'flow' and 'stock' of educational disadvantage within an area respectively. That is, the Children and Young People Sub-domain measures the attainment of qualifications and associated measures ('flow'), while the Adult Skills Sub-domain measures the lack of qualifications in the resident working-age adult population ('stock').

#### Interpreting the results

The sub domain data, like the main domain data report, is based on geographical areas called Lower Level Super Output Areas (LSOAs). LSOAs are small areas designed to be of a similar population size with an average of approximately 1,500 residents or 650 households. There are currently 32,844 LSOAs in England and 165 in South Gloucestershire.

Every LSOA in England (32,844) has been assigned a score and a rank for each sub domain. The most deprived LSOA is given a rank of 1, and the least deprived a rank of 32,844. The ranks show how an LSOA compares to all other LSOAs in the country and are easily interpretable.

Caution should be exercised when making comparisons between the ID 2019 and previous indices. It would be valid to state that an area showed an increased level of deprivation relative to other areas if it was ranked in the most deprived 20% of areas nationally based on the 2015 indices but ranked within the most deprived 10% according to the ID2019. However, it would not necessarily be correct to state that the level of deprivation in the area had increased on some absolute scale, as it may be the case that all areas had improved, but that this area had improved more slowly than other areas and so been 'overtaken' by those areas. Similarly, the overall rank of an area may not have changed between ID2019 and ID2015, but this does not mean that there have been no changes to the level of deprivation in the area.

Tables, graphs and maps in this report refer to 'deprivation quintiles'. Quintiles are fifths, the 1<sup>st</sup> quintile being the most deprived fifth (or 20%) and the 5<sup>th</sup> quintile being the least deprived fifth (or 20%).

In this report deprivation quintiles are used to show how LSOAs relate to others within a defined area. Maps and tables in this report use the following schema:



Q1- Most deprived 20% in England Q2- Most deprived 20-40% in England Q3- Most deprived 40-60% in England Q4- Least deprived 20-40% in England Q5- Least deprived 20% in England

# Barriers to housing and services domain

This domain measures the physical and financial accessibility of housing and key local services. The indicators fall into two sub-domains: 'geographical barriers', which relate to the physical proximity of local services, and 'wider barriers' which includes issues relating to access to housing such as affordability.

#### Some facts about South Gloucestershire in this domain...

- This is the domain in which South Gloucestershire is most deprived: 24 LSOAs (15%) feature within the most deprived national quintile seven more than in 2015.
- The highest rates of deprivation in this domain are generally found in rural areas due to the road distances to services and higher average house prices.

We can look at the sub domain data to gain a greater understanding of the causes of deprivation in this domain.

## Geographical barriers sub domain

#### The indicators


Geographical Barriers sub-domain

- Road distance to a post office
- Road distance to a primary school
- Road distance to a general store or supermarket
- Road distance to a GP surgery

#### Key findings

- 44 LSOAs are in the most deprived 20% nationally for the geographical barriers sub domain. That is 27% of the LSOAs in South Gloucestershire.
- The most deprived LSOA in this sub domain is the Oldbury on Severn rural area in Severn Vale ward (E01014962). It is ranked 351<sup>st</sup> nationally.
- Table 1 shows that of the 20 most deprived LSOAs in South Gloucestershire, all have either stayed in the same quintile since 2015 or have fallen into a worse quintile.
- 15 LSOAs fall into the least deprived quintile 9% of all LSOAs in South Gloucestershire.
- The least deprived quintile in this sub domain is the Northville road area in Filton (E01014909). This LSOA is ranked 32,602<sup>nd</sup> nationally.
- The proportion of LSOAs in the first national quintile has increased slightly between 2015 and 2019, from 24% to 27%.
- The Bromley Heath Infants and Junior school area in Frenchay and Downend ward (LSOA E01014901) has seen the greatest relative increase in deprivation, falling 3 national quintiles (from Q5 to Q2) and dropping 16, 469 rank positions.
- E01014905 (Wades road / Mackie road area in Filton) is the LSOA that has seen the greatest relative improvement, rising 12,373 rank positions nationally and moving from quintile 2 to quintile 4.



## Wider barriers sub domain

#### The indicators

#### Wider Barriers sub-domain

- Household overcrowding: The proportion of all households in a LSOA which are judged to have insufficient space to meet the household's needs
- Homelessness: Local authority district level rate of acceptances for housing assistance under the homelessness provisions of the 1996 Housing Act, assigned to the constituent LSOA
- Housing affordability: Difficulty of access to owner-occupation or the private rental market, expressed as the inability to afford to enter owner occupation or the private rental market.

## Key findings

- 1 LSOA in in the most deprived 20% nationally for this subdomain. This is the Pendennis road area of Staple Hill and Mangotsfield ward (E01014977). It is ranked 6,436<sup>th</sup> nationally.
- 31 LSOAs fall into the second quintile (most deprived 20-40% nationally).
- The least deprived LSOA for the wider barriers sub domain is the Court farm road area in Longwell Green ward (E01014934). This LSOA is ranked 29, 248<sup>th</sup> nationally and is in the least 20% deprived.
- Of the 20 most deprived LSOAs in South Gloucestershire, all have either stayed in the same quintile since 2015 or have fallen into a worse quintile.
- LSOA E01014973, the Narrow Lane / Teewell avenue area in Staple Hill and Mangotsfield ward has seen the greatest relative decrease in deprivation between 2015 and 2019, rising 765 ranking positions and moving up one national quintile.
- LSOA E01014943, the area south of Grange school in Parkwall and Warmley ward, has become most deprived to the greatest extent falling 1 national quintile and 4,823 ranking positions.
- The proportion of LSOAs in the least deprived quintile has decreased between 2015 and 2019 dropping from 22% to 13%.

## Map 2: Wider barriers sub domain 2019









## Summary – Barriers to housing sub domains

'Barriers to housing and services' is the domain with the highest level of deprivation in South Gloucestershire with the proportion of LSOAs in the most deprived 20% increasing each year. Analysis of the sub domain data highlights that this deprivation is largely as a result of geographical barriers (access to services) as opposed to wider barriers (availability and affordability of housing). 27% of LSOAs fall into the first national quintile for the geographical sub domain but only 0.6% are in the bottom quintile for the wider barriers domain. The areas that show greater deprivation for the geographical barriers sub domain tend to be rural which explains why they are likely to have greater distances to services such as GPs and schools.

## Living environment domain

This domain measures the quality of individuals' immediate surroundings both within and outside the home. The indicators fall into two sub-domains: the 'indoors' living environment, which measures the quality of housing, and the 'outdoors' living environment which contains two measures relating to air quality and road traffic accidents.

#### Some facts about South Gloucestershire in this domain...

- There are six LSOAs within the most deprived 20% of areas in England for this domain
- The majority of South Gloucestershire's LSOAs are within the least deprived 20% of areas nationally for this domain (61% / 101 LSOAs). This is an increase on the 2015 figure suggesting South Gloucestershire has become relatively less deprived in this domain.

## Indoors living environment


The indicators

Indoors sub-domain

- Houses without central heating: The proportion of houses that do not have central heating
- Housing in poor condition: The proportion of social and private homes that fail to meet the Decent Homes standard.

## Key findings

- 11 (7%) LSOAs are in the most deprived 20% for this sub domain. This is 2 more than in 2015 (9).
- Of the top 20 most deprived South Gloucestershire LSOAs, all have remained in the same or worse quintiles than in 2015.
- The most deprived area in South Gloucestershire is LSOA E01014891, the Tomarton area in Boyd Valley and Chipping Sodbury wards. It is ranked 589<sup>th</sup> nationally, a decrease of 1,256 positions from 2015.
- The least deprived LSOA is the Colliers break / Johnston road area in Emersons Green ward (E01033336). This LSOA falls into the least deprived 20% nationally and is ranked 32,766<sup>th</sup>.
- LSOA E01014988 (Thornbury Hospital / Knapp Road area in Thornbury ward) has seen the greatest relative increase in deprivation falling 5,290 rank position (1 national quintile) between 2015 and 2019.
- The greatest relative decrease in deprivation was for LSOA E01014872 (Great Meadow Road / Palmers leaze area in Bradley Stoke South). This LSOA rose 13,201 rank positions and 2 national quintiles.
- The distribution of quintiles for this domain remains largely unchanged between 2015 and 2019 with the largest proportion of LSOAs falling into the least deprived quintile for both periods.




## The indicators

Outdoors sub-domain

- Air quality: A measure of air quality based on emissions rates for four pollutants
- Road traffic accidents involving injury to pedestrians and cyclists: A measure of road traffic
  accidents involving injury to pedestrians and cyclists among the resident and workplace
  population.

## Key findings

- Only 1 LSOA features in the most deprived 20% nationally. This is Flaxpits lane and surrounding rural areas in Winterbourne ward (E01015000). It is ranked 6,280<sup>th</sup> nationally.
- The majority of LSOAs in South Gloucestershire are in the least deprived 20% for this sub domain (102 / 62%).
- The least deprived LSOA is E01014991 (Steamleze / High street area in Thornbury). This LSOA is ranked 32,604<sup>th</sup>.
- E01014870 Doynton / Dryham rural area in Boyd Valley is the LSOA which has become more deprived to the greatest extent falling 3 national quintiles and 19,695 rank positions since 2015.
- E01014910 Filton College area in Filton is the LSOA which has become less deprived to the greatest extent rising 3 national quintiles and 17,433 rank positions.
- The proportion of LSOAs in south Gloucestershire in the least deprived quintile has increased significantly between 2015 and 2019, rising from 26% to 62%. This suggests there has been a decrease in deprivation in this sub domain.





## Summary – Living environment sub domains

The majority of South Gloucestershire's LSOAs are in the least deprived quintile for the 'Living environment' domain. The proportion falling into the least deprived 20% nationally for this domain has seen a significant increase between 2015 and 2019. Analysis of the sub domains suggests that this is as a result of limited deprivation in the outdoors indicators (Air quality and traffic accidents) where 62% of all LSOAs are in the least deprived quintile for 2019, an increase of 36% since the ID2015. The indoors sub domain demonstrates higher levels of deprivation although figures are still low with just 11 LSOAs in the most deprived quintile. LSOAs indicating greater deprivation in the indoors sub domain are more likely to be urban whilst those in the lower quintiles for the outdoors domain tend to be in rural areas.

## Education, training and skills domain

This domain captures the extent of deprivation in education, skills and training in an area. The indicators fall into two sub-domains: one relating to children and young people and one relating to adult skills. These two sub-domains are designed to reflect the 'flow' and 'stock' of educational disadvantage within an area respectively. That is, the 'children and young people' sub-domain measures the attainment of qualifications and associated measures ('flow'), while the 'skills' sub-domain measures the lack of qualifications in the resident working age adult population ('stock').

#### Some facts about South Gloucestershire in this domain...

- There are 18 LSOAs within the first national quintile (most deprived 20% of areas in England) three more than in 2015 (15).
- There are 6 LSOAs within the first national decile (most deprived 10% of areas in England) compared to 4 in 2015 and none in 2010.



- Entry to higher education: A measure of young people aged under 21 not entering higher education.

## Key findings

- 35 LSOAs in South Gloucestershire are within the most deprived 20% nationally for this sub domain (21%).
- The most deprived LSOA in South Gloucestershire is E01014941 the area south of Coronation park area in Parkwall & Warmley ward – ranked 673<sup>rd</sup>.
- The least deprived LSOA for this sub domain is the Primrose drive / Squires leaze area in Thornbury (E01014985) ranked 31,647<sup>th</sup>.
- E01014949 Sycamore Drive area in Charlton & Cribbs ward is the LSOA that has seen the greatest relative increase in deprivation, dropping 7,332 rank positions (1 national quintile) between 2019 and 2015.
- E01014924 Downend Road / Worcester Road area in Kingswood ward is the LSOA has become less deprived to the greatest extent, rising 5,399 rank positions (1 national quintile).
- Between 2015 and 2019, this sub domain has seen a slight decrease in the proportion of LSOAs in South Gloucestershire falling into the least deprived quintile (15% to 10%) and a slight increase in the proportion in the most deprived quintile (19% to 21%).







## Key findings

- 5 LSOAs are in the most deprived 20% nationally for this sub domain.
- The most deprived LSOA is E01014926 the New Cheltenham Road area of Kingswood / Woodstock / New Cheltenham wards. It is ranked 3,853<sup>rd</sup> nationally.
- 43 LSOAs are in the least deprived 20% (26% of all South Gloucestershire LSOAs).
- The least deprived LSOA is E01033331 the MOD / Walscourt Farm / UWE west area of Stoke Park & Cheswick ward - which is ranked 31,945<sup>th</sup> nationally.
- The greatest proportion of LSOAs for this sub domain fall into the 3<sup>rd</sup> national quintile (31%). Just 3% are in the most deprived quintile and 26% are in the least deprived quintile.




Chart 9: Education sub domain quintile distribution 2019 (%)

## Summary - Education sub domains

The 'Education, training and skills' domain demonstrates the second highest number of LSOAs in the most deprived quintile in the ID2019 (18 / 11%). There is also a high number of LSOAs in the second most deprived quintile for this domain (44 / 27%). Analysis of the education sub domains enables us to gain a better understanding of the causes of this deprivation. The 2019 data suggests that deprivation in this domain is mostly caused by poor scores for the indicators around education for children and young people. 35 LSOAs fall into the most deprived domain. The children and young people sub domain compared to just 5 in the adult skills sub domain. The children and young people's sub domain has seen an increase in deprivation between 2015 and 2019 with the proportion of LSOAs in quintile 1 rising from 19% - 21%. The adult skills domain shows lower levels of deprivation with 43 LSOAs falling into the least deprived 20% nationally.
