- 3. The Student Nurse must be undertaking a course of study leading to registration on any of Parts 1 to 6, 8, 10, or 11 of the Register maintained under Section 10 of the Nurses, Midwives and Health Visitors Act 1979, as a first inclusion on that Register.
- 4. Please note that nurses undertaking a course of study as part of the Project 2000 training scheme qualify as full-time students and should be entered on Form B for Council Tax purposes.
- 5. A certificate will be issued on request to the student nurse by the College of Health/Nursing and Midwifery (whichever is relevant).
