Your Information

This Privacy Information relates to the personal information we have collected from you about you and your family to receive services available to you and your family via the Families in Focus programme (FiF).

FiF is a multi-agency partnership set up to deliver the national Supporting Families Initiative in South Gloucestershire. We want to improve the lives of families with multiple difficulties and also to reduce demand on services by working early and intensively with them. FiF is an approach not a service and our vision is that we will be able to show that across the Partnership all services will:

- use data intelligently to plan and shape our work with people
- work with the whole family
- · focus on outcomes for families.

To be eligible for Families in Focus each family must be vulnerable in at least three of the following criteria:

- Getting a good education
- Good early years development
- Improved mental and physical health
- Recovery and reducing harm from substance misuse
- Improved family relationships
- Children safe from abuse and exploitation
- Crime prevention and tackling crime
- Safe from domestic abuse
- Secure housing
- Financial stability

All our work will aim to address the needs of the family as a whole.

You should be aware that the information we have been provided with in relation to the above programme may include special data about you and your family, such as information relating to:

- racial or ethnic origin
- religious or philosophical beliefs
- health
- sex life or sexual orientation
- criminal offence

We have made sure we will use your information according to the UK Data Protection laws by establishing the following lawful conditions:

- UK GDPR Article 6(1)(c) processing is necessary for compliance with a legal
- obligation to which the controller is subject (see Applicable Legislation below),
- UK GDPR Article 6(1)(e) processing is necessary for the performance of a task
- · carried out in the public interest or in the exercise of official authority vested in
- the controller
- Additional condition for processing special category data under UK GDPR Article
- 9(2) and criminal offence data under UK GDPR Article 10 is that processing is necessary for reasons of substantial public interest under schedule 1, part 2 of the Data Protection Act 2018

How we'll use your information

We'll use your information to provide the above service you have requested whilst complying with the established lawful conditions. The purpose of this sharing initiative is to support vulnerable families facing multiple disadvantages associated with involvement with South Gloucestershire Council.

We may also share your information with others outside of the Council e.g. regulators and other public organisations for the detection and prevention of crime.

How long we'll keep your information

We'll keep your information for as long as you have a relationship with us. Specific information relating to this service will be retained according to the relevant record retention schedule which can be found here. We may retain anonymised information about the service we provided to help us improve our services in the future.

Transferring your information overseas

Your information is not transferred and stored in countries outside the UK or the European Economic Area (EEA) for the provision of this service.

Your rights

You have a number of rights relating to your information e.g., to see what we hold about you, to ask us to share it with another party, ask us to update incorrect or incomplete details, to object to or restrict processing of it or to make a complaint about how we are handling it.
