# PRIVACY NOTICE FOR BLUE BADGE SCHEME

### Your Information

This Privacy Information relates to the personal information we have collected from your Blue Badge application form.

South Gloucestershire Council is the data controller for the Blue Badge Scheme and we have a legal obligation to process your personal information. We will not be able to assess whether you are entitled to a Blue Badge, without the personal data you provide us with.

You should be aware that the information we have been provided with in relation to the above service includes special category data about your personal circumstances. Where relevant this includes:

- Name
- Address
- Date of birth
- Place of birth
- Gender
- National Insurance Number
- Information regarding any current Blue Badge that you may hold
- Evidence of your identity
- Your photograph
- Information regarding your medical condition(s), treatments and medical professionals
- Information regarding how your medical condition(s) affect you
- Information regarding relevant benefits that you may receive
- Evidence of your entitlement to benefits
- Evidence regarding your medical condition(s)
- Phone Number/Email Address (where provided by you)

Please note: The above information may also be collected from any third party who applies on your behalf. We will also establish that the third party is legally representing you by establishing your consent or a valid power of attorney.

## How we'll use your information

We'll use your information to work out whether or not you are entitled to a Blue Badge.

### Who we can share your information with

We may need to share your information with partner organisations including;

Northgate Public Services for the purpose of processing Blue Badge applications.

We have a legal obligation to share certain of your information with the Department for Transport to be held on the central record of blue badges and for statistical analysis, policy formulation and the prevention of fraud and error.

We also have a public interest reason, which is supported by legislation, to share your data with the Cabinet Office (National Fraud Initiative), Her Majesty's Revenues and Customs, for the purpose of preventing and detecting fraud and error or cancelling a Blue Badge which should not be in issue. If you want to find information on how these companies process and protect your personal information, you need to view their individual Privacy Notices.

We may also use your information to contact you about other benefit schemes that might support your needs.

### How long we'll keep your information

We keep all records relating to Blue Badge applications for as long as you have an active and ongoing application or Blue Badge with us. Even if your Blue Badge application is refused or if your Blue Badge has expired or has been cancelled (your record is closed), we will keep your records for the current financial year and for the six financial years following the year that your record is closed.

### Transferring your information overseas

Your information is not transferred and stored in countries outside the UK or the European Economic Area (EEA) for the provision of this service.

### Your rights

You have the right to access the personal information we hold about you. Any access requests are free of charge.

If the information we hold about you is inaccurate, you have a right to have this corrected and you have the right to request completion of incomplete data.

You have the right to ask us to erase your personal data in certain circumstances ('right to be forgotten').

You have the right to ask us to stop or restrict the processing of your personal data, in certain circumstances. Where possible, we will seek to comply with your request, but we may need to hold or process information to comply with a legal requirement
