Guidance notes

National entitlement

The concessionary fares pass entitles you to free travel on permitted local bus services in England from 9:30am to 11:00pm on weekdays, and at all times on weekends and bank holidays (on production of a valid pass). At all other times you must pay the standard fare, this cannot be reclaimed from the operator or local authorities.

Applicants are only permitted one pass per person and this is provided by the authority where you live. Your pass will be valid until the expiry date shown on the front.

Services in your local area

Pensionable age travelcard

- Within South Gloucestershire, Bristol, Bath and North East Somerset, you can use your travelcard Monday to Friday from 9am through to 2am the next day. At weekends and bank holidays you can use it all day.

Disabled persons and Platinum travelcard

- Within South Gloucestershire, Bristol, Bath and North East Somerset, you can use your travelcard at any time.

You can make journeys into Wales from South Gloucestershire on Newport Bus's T7 service to/from Chepstow and Newport, however the Travelcard is not valid on other services within Wales. You are also able to travel for free on the metrobus (Bristol).

Eligibility for a concessionary Diamond Travelcard

You qualify for a concessionary Diamond Travelcard when you reach the pensionable age applicable for women, irrespective of whether you are male or female. Alternatively you may qualify if you satisfy the disability criteria. To apply your main residence must be within South Gloucestershire. Visitors on a temporary visa and British Nationals whose main home is abroad are not eligible.

Eligibility reason 1 - You are of pensionable age

Applicants are eligible for a Concessionary Diamond Travelcard when they reach pensionable age. This is on their 66 birthday, until May 2026 when the pension age is expected to change.

Eligibility reason 2

- You receive an automatic qualifying benefit

The benefits for automatic eligibility are:

- A. Higher Rate Mobility Component of Disability Living Allowance
- B. Personal Independence Payment (PIP), where you have scored at least eight points against either the PIP 'Moving around' and/or 'Communicating verbally' activities.

The eligible descriptors under the Moving Around activity are:

"You can stand and then move unaided more than 20 metres but no more than 50 metres." (8 points)

"You can stand and then move using an aid or appliance more than 20 metres but no more than 50 metres." (10 points)

"You can stand and then move more than 1 metre but no more than 20 metres." (12 points)

"You cannot stand or move more than 1 metre." (12 points)

The eligible descriptors under the Communicating Verbally activity are:

"You can express and understand basic verbal information with help from someone who is trained or experienced in helping people to communicate." (8 points)

"You cannot express or understand verbal information at all, even with help from someone who is trained or experienced in helping people to communicate." (12 points)

- C. War Pensioner's Mobility Supplement

Eligibility reason 3 - Eligibility under qualifying disabilities

Your disability must be permanent and have lasted at least 12 months, or be likely to last at 12 months or be likely to recur. The disability must have a substantial effect on your ability to carry out normal day-to-day activities.

The qualifying categories of disability are as follows:

- you are registered blind or partially sighted
- you are profoundly or severely deaf
- you are without speech
- you have a disability, or suffered an injury, which has a substantial and long-term adverse effect on your ability to walk
- you do not have arms or have long-term loss of the use of both arms
- you have a learning disability, that is, a state of arrested or incomplete development of mind which includes significant impairment of intelligence and social functioning
- if you applied for the grant of a licence to drive a motor vehicle under Part III of the Road Traffic Act 1988, you would have your application refused pursuant to section 92 of the Act (physical fitness) otherwise than on the ground of persistent misuse of drugs or alcohol.

Replacement concessionary travelcard

There is an administrative charge of £8 to replace a travelcard unless it is due to expire in the next 3 months. You can apply for a replacement travelcard if it is lost, stolen, or you would like to update the photograph. If your pass has been stolen we would advise you to also report the theft to the police.

Renewal of your Concessionary Diamond Travelcard

Where we are able to SGC will carry out a residency check, and if you are still resident in South Gloucestershire and qualified under one of the following categories, your concessionary Diamond Travelcard will be renewed automatically prior to your current travelcard's expiry:

- If you qualified under the 'Eligible due to Pensionable age'
- If you qualified due to being Blind or Partially Sighted
- If you qualified due to being profoundly or severely deaf
- If you qualified as you are without speech or have limited speech
- If you have a learning disability

Please note: we may request a new photograph if we feel this is likely to be out of date.

If you qualified under any other category you will be required to reapply for your concessionary Diamond Travelcard and provide supporting evidence.

If you have moved to the area and do not have a South Gloucestershire concessionary Diamond Travelcard you will need to apply as a new applicant and provide supporting evidence. Passes issued by a different local authority cannot be reissued or renewed by South Gloucestershire Council.

The concessionary travel team will aim to issue approved concessionary Diamond Travelcards prior to the expiry of an existing card. Please note that if an application is not complete, or necessary supporting evidence has not been submitted, there will be a delay in assessment.

Change of address or personal detail

If you are moving address or your personal details have changed, it is important to contact the concessionary travel team.
