## Explanatory Notes

## **Transitional Arrangements**

The transitional arrangements can be summarised as follows:

(a) A scrap metal dealer who is registered on or before the 1<sup>st</sup> October 2013 either as a scrap metal dealer, itinerant scrap metal dealer or motor salvage operator will be deemed to be authorised by a licence under this Act.

(b) if a registered scrap metal dealer or motor salvage operator fails to submit an application for a licence in accordance with this Act on or before the 15<sup>th</sup> October 2013, the deemed licence will lapse on the 16<sup>th</sup> October 2013.

(c) Lapsing of a deemed licence shall not be considered as a revocation and does not give rise to any appeal rights

(d) Where a previously registered scrap metal dealer submits an application on or before the 15<sup>th</sup> October and it is refused, the refusal shall be of no effect until such time as an appeal is resolved.

(e) Pending an appeal against the refusal of an application, if the licensing authority considers that deemed licence should not continue in force without conditions it may by way of notice apply the conditions to the licence to the deemed licence until such time as a refusal may have effect.

(f) The obligations to maintain a register by the Environment Agency does not apply in respect of deemed licences. Neither do the obligations to display the licence.

The following provisions of the Act do not come into force until the 1<sup>st</sup> December 2013:

- (a) Offence of carrying on a business of being a scrap metal dealer without a licence;
- (b) Failing to comply with notification requirements;
- (c) Closure of unlicensed sited;
- (d) Offence of failing to comply with requirements to display licence;
- (e) Offence of failing to verify supplier's identity;
- (f) Offence of failing to comply with record keeping requirements; and
- (g) Offences of failing to apply to vary a licence and making a false statement.

## Making an Application

## Section 1 – For everyone

This section asks if you are applying for a collector's licence or a site licence. You may only apply for one type of licence in each local authority area, but you can apply to run multiple sites. For instance, you could apply to run 3 sites in South Gloucestershire Council's area and also apply to be a collector in another Council's area.

Site Licence

A site licence lets you buy and sell scrap metal from a fixed location within the Council area.

## Collector's licence

Allows you to travel within the Council area to collect scrap metal. You may not take this metal back to a site that you run within the Council area in order to sell it. You must complete the relevant appendix dependant on if you are seeking the collectors licence as an individual, company or partnership. You will need to ensure that all your vehicles are roadworthy and are properly taxed, insured and otherwise meet the legal requirements to be on the road.

## Motor Salvage Operators

This section asks if you will be salvaging motor vehicles as part of your work. The Scrap Metal Dealers Act 2013 brings together the Scrap Metal Dealers Act 1964 together with Part 1 of the Vehicles (Crime) Act 2001, which means you now only need a scrap metal dealer's licence. You will need to apply for a site licence to operate as a motor salvage operator.

## Applicants

You will need to complete the relevant appendix dependant on whether or not you are applying as an individual, partnership or company. You must provide all the information requested.

You and every person listed on the application form needs to submit a Basic Disclosure Certificate from Disclosure Scotland. You can apply for this certificate at <a href="http://www.disclosurescotland.co.uk/apply/individuals/">http://www.disclosurescotland.co.uk/apply/individuals/</a>. This is because the Home Office has decided that you and any person listed on the application need to tell the council if you have been convicted of certain crimes. Possessing a conviction may not automatically prevent you from having a licence if the offence was unrelated to being a scrap metal dealer or a long time ago, and you can convince the council that you are a suitable person. A Basic Disclosure Certificate is considered to be only valid for a limited time, but can be

used to apply to as many local authorities as you want within that time. Typically, three months is the longest that you can expect your check to be considered valid.

A director or partner is someone who has or shares legal responsibility for the operation of the company, including filing returns at Companies House.

#### Section 2 – Bank accounts that will be used for payments to suppliers

This section asks you for the bank details which you will use to pay people for the scrap metal you receive or sell. This is to check that you are not selling the metal for cash, which is illegal. These details will be kept securely by the Council.

#### Section 3 – Criminal convictions – All applicants

This section asks you to set out any relevant convictions or enforcement activity that has been undertaken against you by the Environment Agency or Natural Resources Wales. It is an offence under the Scrap Metal Dealers Act 2013 to make or recklessly make a false statement. The information listed here will be checked against the Basic Disclosure Certificate from Disclosure Scotland that you are required to submit with the application, along with information retained by the Police and the Environment Agency or Natural Resources Wales.

#### **Section 4 – For site licences**

If you want a **site licence** you will need to complete Appendix 4. We will need to know the address of the site or sites you want the licence for, as well as the details of each site manager responsible for that site including their home address. These details are required by law or to facilitate checks on the applicant or so that you can be contacted if there are any problems. A **site manager** is the person who will be in charge of the site on a daily basis.

#### Section 5 - For sites in another local authority area

We also want to know if you operate or propose to operate a site in another local authority area, along with details of this site, the Council which has licensed it or to whom you have applied for a licence. If your site(s) were established after 1990, then you are required to have planning permission from the Council. You will need to tell us if this is the case, and it will be checked with the council planning department.

# Section 6 – Details of current registrations, permits, etc (Definitions of registrations etc to be added)

In order to carry on your business you may need to hold other environmental permits or licences that we should know about. For instance, if you carry waste as part of your business it is a legal requirement to register as a waste carrier. This includes transporting waste while travelling from job to job, to a storage place for disposal later, or to a waste disposal company or waste site. This section also asks for details of any other scrap metal licences you hold. Please make sure you include the licence number so that we can check this against the national register.

#### Section 7 – Payment

There is a fee to apply for a licence and your Council will tell you how you can pay. The fee varies from Council to Council as it reflects their costs of processing the form and checking that people are doing what the licence requires. Applications cannot be accepted unless the correct fee has been paid.

#### Section 8 – Declaration

The person who will hold the scrap metal dealer's licence needs to sign and date the declaration, as do the other people named on the form. This section also explains that the Council has to share some of these details with the police, Environment Agency, or Natural Resources Wales when checking whether the applicant(s) is a suitable person to hold a licence. Some of the information will also be displayed on a public register. If you do not agree to this use of your information then you should **not** sign the form. If you are in

any doubt about what this section means then speak to you should seek your own legal advice or ask the licensing office if they can be of help.

## **Relevant offences**

- Proceeds of Crime Act 2002: Sections 327,328,330,331,332 (environmental/metal theft related offences only)
- Producer Responsibility Obligations (Packaging Waste) Regulations 2007
