Dear Business owner/Manager,

We know it has been a difficult time and we are here to help you reopen and manage the challenges.

The Government has announced that businesses will be permitted to open in stages (see below) to prevent the spread of coronavirus. Please be aware that before opening, businesses are required to complete a risk assessment. Template risk assessments can be found in your business toolkit or online at www.southglos.gov.uk/making-public-places-safer

- Essential businesses have been operating through the period of lockdown.
- From 1 June, outdoor markets and car showrooms were allowed to trade.
- From 15 June 'non-essential' retailers can commence trading.
- From 4 July the remaining businesses and premises, including hairdressers, hospitality venues, and public spaces including places of worship will reopen.

As a business community we want to work together to ensure visitors feel safe and have the confidence to come back to our shops, our businesses and engage with the services we provide. To help the general public feel comfortable and safe to return to our high streets and help to restart the economy, it is vital that we all work to adjust how our high streets are used in order to manage queues and facilitate social distancing for pedestrians. We recognise that a sustainable future high street has to be an inviting and safe place that offers an experience to the consumer. For these reasons we are working to implement a range of measures including pedestrianising Thornbury high street, introducing temporary traffic control measures, creating dedicated walking and cycling zones and improving signage in order to help the general republic return to the high street as quickly and as safely as possible. Expanded public space will also provide businesses space for additional trading opportunities and for collective resources to come together and promote new activities and experiences in our high streets. As part of our commitment to supporting High Streets as we recover from Covid-19, we are waiving our fee for licensing applications to trade outside of existing business premises. This is to enable cafes, restaurants and pubs to operate with social distancing in place, we are also waiving the requirement to gain planning permission for outside seating areas. You will need to submit an application form which is available on our website and we will contact you to arrange a site meeting to confirm arrangements for the tables and chairs. You will need to confirm your public liability insurance but not necessarily to the value of £5million.
